



## **PRIVACY STATEMENT “ VZW LIVING WATERS VILLAGE BORNEO”**

### **Privacy statement**

The “VZW Living Waters Village Borneo” highly values the protection of your personal data and ensures that the personal information you provide us with will be treated with confidentiality. In this we want to give you clear and transparent information about what information we collect and how we deal with personal data.

We do everything we can to guarantee your privacy and therefore handle your data carefully. “VZW Living Waters Village Borneo” follows the rules governing the General Data Protection Regulation (AGV).

### **Which personal data are processed?**

We only process data that you gave us and only for the purposes for which we obtained it. We can request and process the following personal data from you: name, first name, title, address, telephone number, e-mail and Bank account number. We also know which child is possibly sponsored by you.

### **Security of your data**

We have taken appropriate measures to protect your personal data against unlawful processing:

- We only use your personal data for the purposes for which we have obtained them.
- The processing of your personal data is limited to only those data that are minimally required for the purposes for which they are processed.
- We do not pass on personal data to other parties, unless this is necessary for carrying out the purposes for which they were provided.

- All persons who on behalf of VZW Living Waters Village Borneo can see your data, have been informed about the importance of the protection of personal data.
- We back up the personal data to be able to recover these in case of physical or technical incidents.
- We use various security technologies and - measures to adequately protect your data against unauthorized access, use, loss or disclosure.
- Financial transactions are processed in our accounts and saved according to the applicable legal provisions.

### **Storage period**

VZW Living Waters Village Borneo does not store personal data longer than necessary for the purpose for which they were provided or on the ground it is required by law.

### **Your rights regarding your data**

- You are entitled to inspect and correct your personal data. On request we can also delete your personal information unless there are legal guidelines that do not allow this (eg financial transactions in accounting). You can also object against processing your data (or a part of it) by us or by one of our processors. - For newsletters sent by post, you can at any time unsubscribe by sending an email to [info@heyboer.org](mailto:info@heyboer.org)
- If you have a complaint about the processing of your personal data then we ask you to contact us directly. You always have the right to file a complaint with the Privacy Commission, the supervisory authority in the field of privacy protection.
